(a) Pre-Proposed Residential School Reconciliation

Ron Couchie enquired as to whether Council had given consideration to his Residential School Reconciliation Ad-Hoc Committee request or whether he should he proceed by creating a proposal for gathering information and statistics on the effects of Residential School. Council advised him that in order to give an answer there needs to be a plan in place or something in writing outlining the goals and timelines to meet those goals. Suggestions were made that how would this committee overlap some of the departments like the health centre and the cultural department's programming and services. Council suggested that Ron prepare a proposal in detail on moving forward with his request in order to get a definite answer.

Amendments were suggested by council to change the wording in section 6. Size "Walleye (yellow pickerel) to pickerel. Clint advised that he can provide monthly updates to Council providing information from Fisheries Department on data collected.

- I.Energy East Dwayne informed council that NFN has submitted its Intervenor application and funding request. The decision is with National Energy Board now who are dealing with the largest number of participation requests they've ever seen. He anticipates the decision on participants may be delayed and will update council as soon as receives any information.
- II. Office Expansion Dwayne was seeking approval from Chief and Council to explore options to finance an addition to the Administration office to accommodate the Lands currently housed in portables at the office and other programs. We will also seek to consolidate other First Nation services and programs (Housing, etc.). While staff will be directed to pursue funding opportunities from external sources, management believes these opportunities are fairly limited. We have completed a review of the three proposals from local architectural firms and recommend proceeding with Mitchell Architects.

- III. Duchesnay Road Upgrades Dwayne asked Council approval to secure funds and budget to resurface Couchie Memorial Drive this spring and summer. In doing so this will require the replacement of existing water lines first before resurfacing the road.
