He informed Council that Nipissing First Nation has stated their position on this matter with regards to the infringement in our traditional territory as well as the Robinson Huron treaty area.

Band Member Issues – Chief McLeod informed Council that he has been dealing with band member issues, the majority concerning housing. Housing Policies are in place to address these issues.

Brendan Huston, Chief Executive Officer provided a written report to Council that provided an update on Covid-19 and vaccine update.
